* Indian nationals traveling to the Philippines as tourists may be granted visa-free entry for stays not exceeding fourteen (14) days, provided they possess the following:

- a. Any valid US, Japanese, Australian, Canadian, Schengen, Singapore, or UK visa or permanent residence permit;
- b. Passport should be valid at least six (6) months beyond the intended period of stay;
- c. Return or onward ticket to the next country of destination;
- d. No derogatory record with the Bureau of Immigration (BI), the National Intelligence Coordinating Agency (NICA), and the International Police (Interpol);

* This visa-free entry is applicable only for arrivals at Ninoy Aquino International Airport (NAIA) Terminals I, II, III and IV.

* This type of admission will be non-convertible to other visa categories.

* When in the Philippines, Indian nationals are allowed to apply at the Bureau of Immigration (BI) for a one-time extension of their stay for seven (7) days, for a total stay of twenty-one (21) days.

* If the visitor intends to stay for more than twenty-one (21) days, he should apply for a visa at the Philippine Embassy in New Delhi or at any Philippine Embassy or Consulate in a country where the applicant has legal residence.
